Their journeys bring to life stories like Ebony's--she received her certificate as a medical assistant to further her career and solidify a strong future for her family--or stories like William's--a five-year-old whose trauma once hindered his ability to speak and connect with others. With the support of our therapeutic partners, William graduated from our program and stepped into kindergarten strong, confident, and thriving. These are just two of the many moments that shine as reflections of our values, our mission, and our vision.

Our historic 2024 wasn't just about change—it was about laying the foundation for more of these moments, amplifying our impact, and deepening our commitment to the families we serve. With our new Strategic Plan, we have sharpened our focus on the values that guide us: Collaboration & Teamwork, Accountability & Leadership, Inclusion & Equity, Caring & Compassion, and Integrity & Trust.

We enhanced several of our core programs this year by deepening partnerships with mental health counselors to offer more comprehensive support for parents, restructuring our case management model to better meet families' needs, and expanding therapeutic services for children. We are especially proud of the stronger, more collaborative relationships we've built with community partners allowing us to serve more families and serve them better.

2024 was a year of laying groundwork, but more importantly, it was a year of impact. Every number, every story, and every milestone in this report reflects the dedication of our supporters, staff, and families. Together, we move forward to an Atlanta where homelessness is defeated and every child has a safe and nurturing home.

Victoria & Elijah

After a broken foot left Victoria unable to work as a valet parking supervisor, she and her two children, Jamie (8) and Elijah (2), were shuffled between family members. Searching for 6 months, Victoria struggled to find affordable housing. Then Elijah's preschool changed its operational hours, leaving Victoria without childcare and still without a home.

Then, Atlanta Children's Day Shelter entered their lives. Elijah was enrolled in our early childhood education program while Victoria participated in our parent services. When first enrolled, Elijah was struggling with emotional expression, a vital skill for conflict resolution. Often, Elijah would feel an emotion, and then shut down as Victoria puts it. But with play therapy and help from his teachers, Victoria says Elijah "learned to trust people outside of myself, and understand that there are other adults that actually care about him too."

For Victoria, this support of Elijah in expressing his emotions was further evidence that the Day Shelter was the right place for her and her family: "I think that was the best part of about it--I was not alone in those transitions with him... It was just an open door."

With Elijah safe and cared for at the Day Shelter, Victoria could fully focus on her housing and employment search, quickly securing both. Once Victoria and Elijah had the right support, the entire family thrived!


In 2024, Victoria's family graduated to our Steps2Success program.

Our Steps2Success program provides continued wraparound support to families whose students have graduated from our ECE program or whose families have met their initial case management goals. In the case of Victoria's family, they'd met both!

To ensure all our parents reach their goals, in 2024, Our case manager we implemented a strengths-based approach to and adult therapist now our model of care. work in closer collaboration to connect clients to the resources needed. Our adult therapist sets up a safe space that helps our clients learn strategies for improved mental health, and in that safety, clients can express what resources may be missing and then be further connected with their case manager. On the other side, case managers foster an achievementoriented space where clients feel supported in pursuing their goals. In that environment, clients may identify mental health needs, leading to further connection with a therapist. This integrated model streamlines the efficiency of service access, providing a clearer and more efficient path to the resources they need.

Our case manager, Akira, values our new strengths-based approach. She says, "Everyone works together collaboratively for the betterment of the children, their parents, and families. I think that's what makes it so effective."



Elijah received impactful care from our Early Childhood Education program.

In 2024, we worked to make sure this care is consistent by stabilizing our classroom workforce. **We had a 94% teacher retention rate in 2024**, bringing our students more consistent, quality care.

Elijah benefitted significantly from our play therapy program, which helped him learn healthy emotional expression. Our play therapy program plays an essential role in helping our students recover from homelessness. With an emphasis on early intervention, play therapy allows children to process trauma, build resilience, and create secure attachments, all for a brighter future. Our dedicated play therapists work to help our kiddos express their inner world through play, then guide our students in developing coping mechanisms, augmenting social skills, and resolving emotional conflicts. Services like play therapy are instrumental in achieving our mission.

In 2025, we're amplifying our play therapy program with Parent Pods, groups dedicated to building community amongst parents and translating the skills their students are learning in play therapy!


